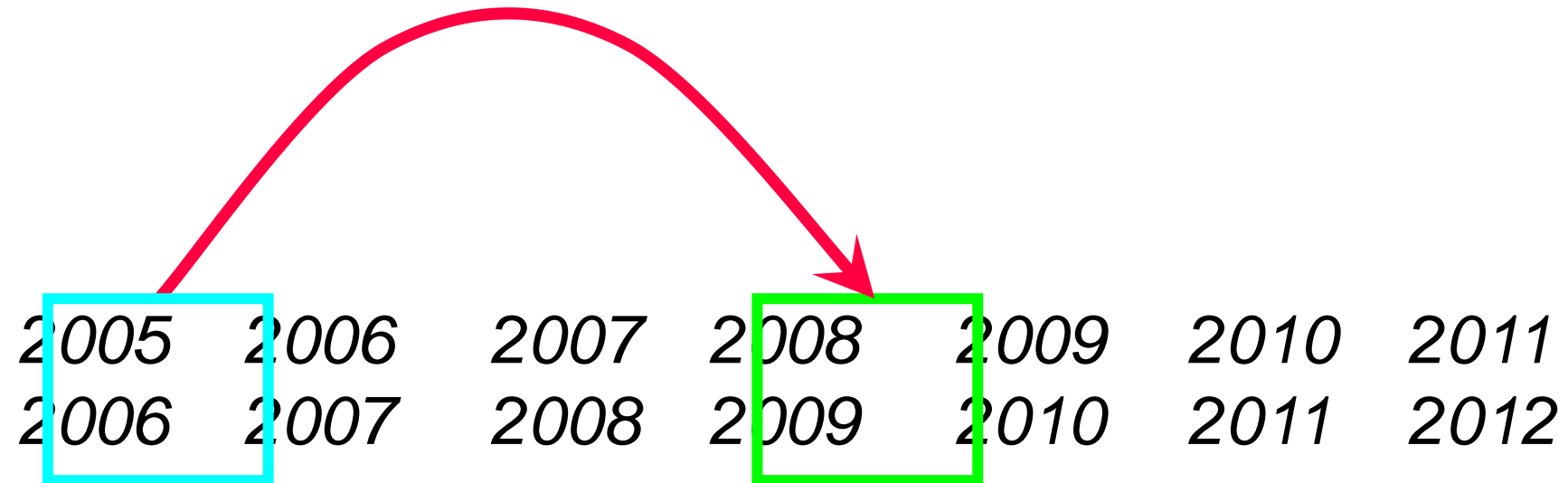
Fondul anual

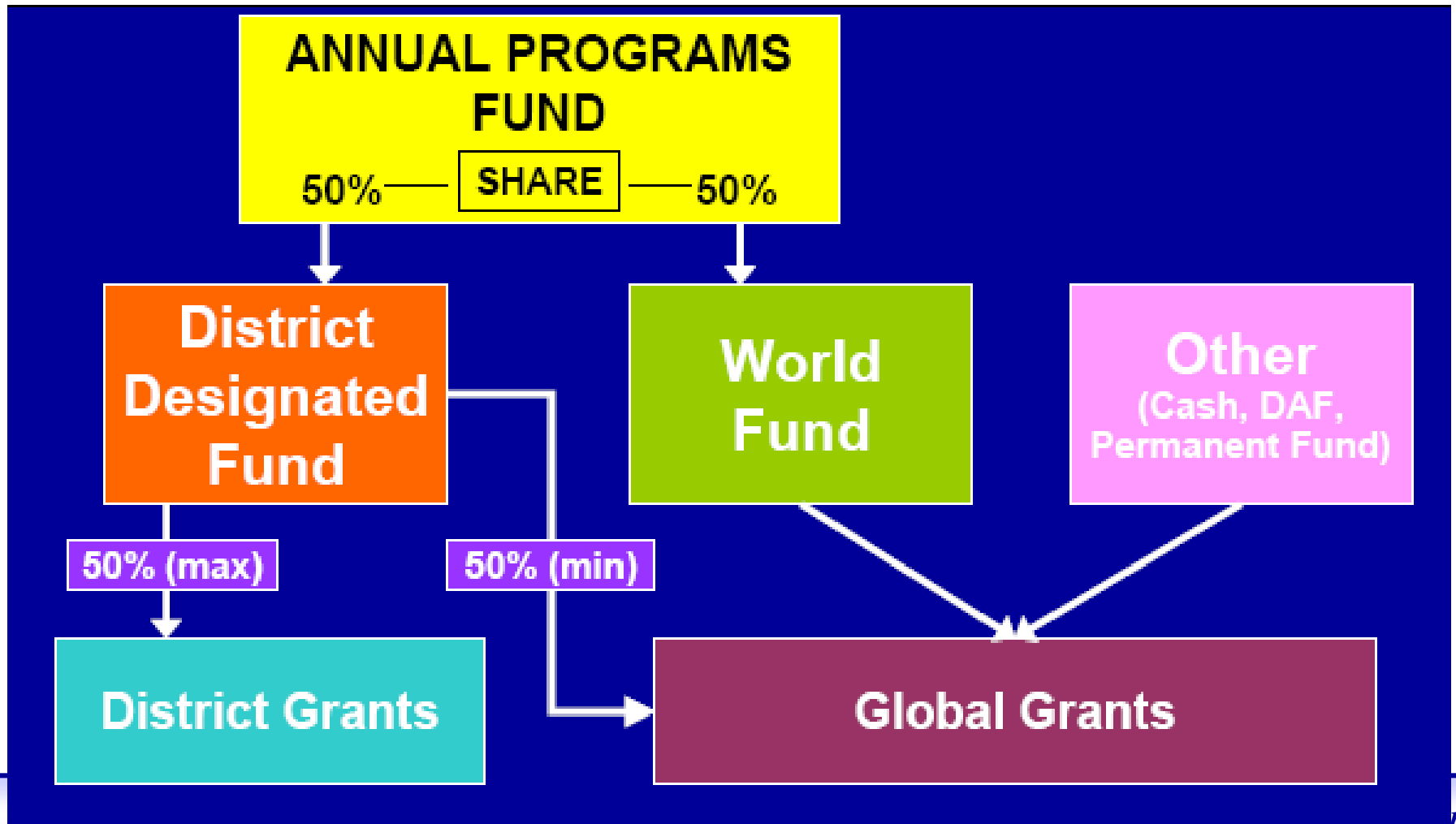

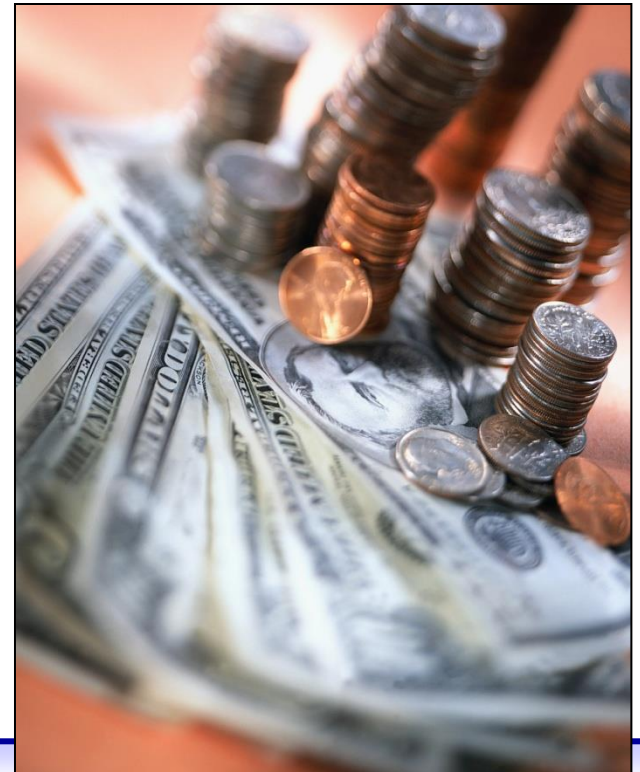
Model de distributie a fondurilor
